## Terms & Conditions

1. **Deposit:** Payment of the deposit of **\$20%** of booth space rental (\$599 for a 10'X10' standard booth) must be submitted with application.
2. **Application for Exhibitor Space:** Application for Exhibitor will be taken on a first come, first served basis. Exhibitors will be placed on the exhibition floor in order of postmark, fax date, or Internet time stamp (email) plus payment. The Application must be postmarked no later than February 28, 2008 for lowest rates. After February 28, 2008 Normal Rates Apply.
3. **Payment of Exhibitor Space:** Rental for the Exhibitor Space will be paid to 1Christian.Net according to the following schedule:
  - Deposit – 20% of booth space rental – **REQUIRED FOR APPLICATION TO BE ACCEPTED.**
  - Payment 2 – ½ of remaining balance – Due 30 days after application is accepted.
  - Final Payment –remaining balance – Due no later than April 30, 2008.
4. **Cancellation of Exhibit Space:** In the event of reduction of space or cancellation, booth space deposits are non-refundable after 5 days from contract acceptance. Thirty days after application acceptance date, 50% Payment 2 is non-refundable or, if payment has not been made, due if the exhibitor elects to downsize or cancel exhibit space. After April 30, 2008, 100% of the booth cost is non-refundable or, if payment has not been made, due if exhibitor elects to downsize or cancel exhibitor space.
5. **Late Fees:** If exhibit space is not paid in full before April 30, 2008 1Christian.Net herein known as (1CN) may: (i) assess a late fee of fifty dollars (\$50) per booth space; (ii) treat exhibitor's failure to pay as notice of Exhibitors intent not to use its assigned space and require a reinstatement fee of fifty dollars (\$50) per booth space.

7. **Booth Size:** Booth sizes are approximate.
8. **Booth Amenities:** If desired the following may be included with each Booth Space. (Booth does not include, electricity service greater than 10 amps, floor covering, decorations, furnishings, or other services.)

3' Divider (Will be provided between booths unless requested that we do not.)

1 full-page ad will be placed in Summit Book (insert provided by sponsor, call for specifications )  
A 30 second, video (only), Commercial to be shown over Exhibition Hall big screens.
9. **Exhibiting Rules and Regulations:** Exhibitors shall abide by the provisions set forth for the East Coast Worship Summit herein known as (ECWS).
  - (a) One (1) person shall be at the booth during exhibition hours.
  - (b) Exhibitor will not sublet or share its exhibit space with any other entity unless agreed on by ECWS in advance and in writing. Exhibitor will not display or sell any other entities information or products unless agreed on by ECWS in advance and in writing.
  - (c) Exhibitors will refrain from having conflicting activities during all general sessions and workshop sessions.
10. **Exhibitor Contract is not a Transferable Asset:** Neither the assigned booth Space, nor any portion thereof, nor Exhibitors interest therein shall be assigned or otherwise transferred by exhibitor without prior written permission of East Coast Worship.
11. **Limitations of liability:** Neither 1CN, ECWS, Church of the Saviour herein known as (COS), their officers, directors, agents, employees, affiliates, or volunteers shall be liable to Exhibitor for any injury, loss, or damage to the person or property of Exhibitor, its officers, directors, agents, employees, or invitees, except to the extent that such injury, loss, or damage is caused directly and by substantial negligence on the part of 1Christian.Net, or its employees.
12. **Compliance With Applicable Laws and Indemnifications:** Exhibitors will strictly comply with all laws pertaining to its exhibition at the ECWS, but not limited to, laws pertaining to copyrights, trademarks, antitrust, promotions, and giveaways. Exhibitor will indemnify 1CN, COS and its entities and hold them harmless from any and all liabilities in respect to suits, proceedings, demands, judgments, damages, expenses, and costs (including, without limitation, reasonable attorney's fees and costs and expenses incurred in the investigation, defense, or settlement of any claims covered by this indemnity) which 1CN, COS and its entities may suffer or incur by reason of participation in the East Coast Worship Summit by exhibitor, its officers, directors, agents or representatives.
13. **Breach of Contract and Violation of Rules and Regulations:** Following acceptance and execution of this application by 1Christian.Net, any breach of the resulting contract by exhibitors, its officers, agents, or employees may, in 1CN's discretion, result in immediate loss of exhibitors privilege. Following execution of Exhibitors application by 1CN, 1CN's liability for breach of the resulting contract shall be limited to the space rental fee paid to 1CN by exhibitor. In no event shall 1CN be responsible for consequential damages. Any bankruptcy filing of any kind or insolvency shall constitute a breach of this Application and contract.
14. **Severability:** If any provision in this Application for Exhibit Space is determined to be unenforceable, all other provisions shall continue in full force and effect.
15. **Acknowledgement and Warranty:** Exhibitor acknowledges and warrants that the individual signing this application for exhibit Space on its behalf has been duly authorized to do so.
